USE OF COOKIES AND ACTIVITY FILES

IP ADDRESSES

Our web servers will be able to automaticly detect the IP address and domain name used by the user. An IP address is a number automaticly assigned to a computer when it connects to the Internet. SECURITY

INTERNATIONAL DATA TRANSFER

Colectalia.com is hosted in a server in the United States of America, and all the personal data supplied during the sign up for a customer account are transferred to that country. When a user signs up for an account in Colectalia.com, must give us his explicit consent to internationally transfer his data to the USA, in order to store his data, as per the assumptions of the Spanish laws, article 34 of LOPD and 66.2 of RLOPD. For this reason, any user signing up in Colectalia.com, must check the box at the bottom of the registration form, accepting our Privacy Policy, and thus explicitly allowing us to do this international transfer of data. If that box is not checked, the sign up will not be possible.

We remember to our customers that the only personal data we ask to sing up are name, surname, email, street and number, ZIP code, city and country. Optionally, they can also provide data about title (Mr. Ms or Mrs), date of birth, telephone and cellphone and company. We do not require neither keep any kind of financial information, as we only accept payments through PayPal, Skrill, bank wire or cash on delivery.

The same conditions apply for the subscriptions for our newsletter, with the only difference that only an email address is required to get a subscription.

Any customer can revert at any time his consent given to us to store his personal data in our US servers, but deleting a customer's data from our server will also imply to delete his user account and to unsubscribe from our newsletter.
